A physical therapist shall manage all aspects of each patient's physical therapy. A physical therapist shall provide: each patient's initial evaluation and documentation, periodic reevaluation and documentation of each patient, and the documented discharge of the patient, including the response to therapeutic intervention and the time of the discharge.

Limited Liability Company Act

A limited liability company may merge with one or more other constituent organizations pursuant to this section, sections 10-32.1-55 through 10-32.1-59, 10-32.1-71, and a plan of merger if: the governing statute of each other organization authorizes the merger; the merger is not prohibited by the law of a jurisdiction that enacted any of the governing statutes; and each of the other organizations complies with its governing statute in effecting the merger.
