AN ACT relating to health care; prohibiting discrimination in the provision of health care services and insurance for organ transplants and related procedures based on a person's disability; providing definitions; providing for enforcement and authorizing a civil action; and providing for an effective date.

# HB 162

ACT relating to Medicaid; providing for the expansion of Medicaid eligibility; limiting the continued expansion of Medicaid eligibility as specified; repealing prior authorizations; and providing for an effective date.

# HB 83

AN ACT relating to health care services; prohibiting the delivery of health care services as specified on more favorable terms or conditions for insured than for uninsured persons; imposing civil liability for alleged violations by health care service providers; amending the Wyoming Governmental Claims Act accordingly; providing definitions; and providing for an effective date.

# SF 104

AN ACT relating to professions and occupations; providing for the licensing of anesthesiologist assistants and specifying scope of practice; creating and amending definitions; creating an advisory committee to the board of medicine; providing for the imposition of fees; creating a criminal penalty; providing for a hearing; requiring rulemaking; and providing for an effective date.

## **Wyo. Stat. § 26-3-401. Report of material transaction: Disclosure of Material Transactions**

Every insurer domiciled in this state shall file a report with the commissioner disclosing material acquisitions and dispositions of assets or material nonrenewals, cancellations or revisions of ceded reinsurance agreements unless the acquisitions and dispositions of assets or material nonrenewals, cancellations or revisions of ceded reinsurance agreements have been submitted to the commissioner for review, approval or information purposes pursuant to other provisions of the insurance code, department regulations or other requirements.
